PRIZE DRAW TERMS AND CONDITIONS

NO PURCHASE NECESSARY TO ENTER OR WIN.

A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

Promoter: Universal Music Canada, 2450 Victoria Park Ave, Toronto, Ontario M2J 5H3

Promoter's decisions are final and binding in all matters relating to the **Johnny Orlando Video Shoot Contest**; referred hereafter as the "Prize Draw".

Prize Draw Entry Period: Prize Draw begins at 10:00 AM EST on the 6th of July 2018 and ends at 2:00 PM EST on the 12th of July 2018 ("Prize Draw Entry Period").

Eligibility: Prize Draw is open to any person who has reached the age of majority in the state, province or territory where s/he resides and who at time of entry is a legal resident of one of the following countries: Belgium, Canada (except residents of the province of Quebec); France, Germany, Italy, Netherlands, the United Kingdom (defined as: England, Northern Ireland, Scotland and Wales); and the 50 United States (including the District of Columbia). Void in the province of Quebec and where prohibited by law. Employees of the Promoter and its respective parent company, subsidiaries, affiliates, advertising and promotion agencies, and any other individual or company involved in the development or execution of the Prize Draw (collectively the "Released Parties) and their immediate family members and/or those living in the same household of each are not eligible to enter or win. Method #2: A no purchase option, by going to www.umusic.ca/contests and filling out the online contest form. By filling out the form, entrant receives one (1) digital ballot to be used in the draw. Entries must include all requested information to be eligible. Any use of automated devices is prohibited.

For all methods of entry: Method #1 Unlimited entries based on streaming

Method #2: one (1) entry per person/email address per method during the Prize Draw Entry Period.

Only complete and valid entries as determined by the Promoter and/or the Administrator will be eligible for the Prize Draw. By participating in the Prize Draw each Entrant is confirming that they have read and agree to comply with these Terms and Conditions ("Rules"), Promoter's terms of use, located at <http://privacypolicy.umusic.com/terms/> and all other Prize Draw requirements.

Winner Selection: Potential Winner ("Winner") will be selected at random from among all eligible entries received during the Prize Draw Entry Period. The Prize Draw will be conducted on

or about 3:00 PM EST on or about the 12th of July, 2018 at the offices of the Promoter (2450 Victoria Park Ave, Toronto, ON, M2J 5H3) whose decisions are final and binding. An email prize notification or direct message will be sent to the potential winner based on the information provided by participant on the Entry. Potential winner will be required to execute and return a Declaration or Affidavit of Eligibility and Liability as determined by the Promoter or Promoter's agent and, unless prohibited by law, Publicity Release ("Affidavit/Release") within one (1) day of date specified on notification or he/she will be disqualified, and an alternate winner will be selected.
